**BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and
 Recommending Approval**

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of IT Equipment and Accessories in the PhilGEPS and posted the same in the VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Five (5) bidders purchased bidding documents and submitted applications for eligibility and joined the bidding for the said IT Equipment on 21 May 2014;

WHEREAS, after checking the eligibility requirements, the BAC declared that all bidders passed the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, only three (3) bidders passed the technical requirements while the two (2) bidders failed to comply two of the requirements (Technical Specifications and Production/Delivery Schedule);

WHEREAS, after all the bids were ranked and marked on the abstract of quotation, the BAC identified the **Lowest Calculated and Responsive Bid (LCRB)** for each item as shown in the table below with corresponding justification in the "Remarks" portion.




