**BAC RESOLUTION Declaring Failure of Bidding and Recommending Approval for the  
Revised Technical Specifications and Adjusted Approved Budget of Contract**

**WHEREAS**, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of IT Equipment in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

**WHEREAS**, in response to the said advertisement, One (1) bidder purchased bidding documents and submitted application for eligibility and joined the bidding for the said IT Equipment on 11 September 2014;

**WHEREAS**, after checking the eligibility requirements, the BAC declared that the lone bidder passed the preliminary examination of bids;


**WHEREAS**, upon detailed evaluation of the technical component, the BAC found out that the bidder failed to comply the technical specifications. The BAC then informed the end user of his disqualification;

**WHEREAS**, as a result of the disqualification of the lone bidder due to his failure to comply the technical specifications, the BAC Technical Working Group (TWG) conducted a mandatory review and evaluation of the specifications including its cost estimates. Based on the findings, the end user was requested to revise the technical specifications and adjust Approved Budget of Contract (ABC);

**NOW, THEREFORE, based on the above premises**, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED:

- a) To declare **FAILURE OF BIDDING** for Supply and Delivery of IT Equipment and to conduct a re-bidding with readvertisement and/or posting, as provided for in Sections 21 and 25 of the Revised IRR.
- b) To recommend for approval by the President of the Visayas State University for the revised technical specifications of IT Equipment and the adjusted Approved Budget Contract (ABC); and
- c) To recommend for approval by the President of the Visayas State University the foregoing findings.
