## BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and Recommending Approval

## BAC RESOLUTION NO. 03 Series of 2015

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for Laboratory Equipment in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Twelve (12) bidders purchased bidding documents and joined the bidding for the said Laboratory Equipment on 28 April 2015;

**WHEREAS**, after checking the eligibility requirements, the BAC declared that all bidders *passed* the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, the BAC declared that all the bidders passed the technical requirements.

WHEREAS, after all the detailed evaluation of the technical specifications, all the bids rated passed were tabulated and ranked, the BAC identified the **Lowest Calculated Bid** (LCB) for each item (marked red) and the next in rank bidders (marked blue) as shown in the attached Abstract of Quotation.

WHEREAS, on 07 May 2015, the BAC conducted a Post-Qualification to determine the Lowest Calculated and Responsive Bid (LCRB) taking into consideration compliance of the specifications. In addition, the end users of the equipment were asked to make a justification on the choice of equipment other than the lowest bidder. The table below summarizes the results of the Post qualification:
