**BAC Resolution Declaring Second Failure of Bidding for the
Supply and Delivery of Motor Vehicles for VSU Main Campus
and Recommending Approval for Negotiated Procurement**

BAC RESOLUTION NO. 06
Series of 2015

WHEREAS, the **VISAYAS STATE UNIVERSITY** re-advertised the Invitation to Apply for Eligibility and to Bid for Supply and delivery of Motor Vehicles in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, a public bidding was held last 26 May 2015, 10:00 AM at the Conference Room of the Office of the Vice President for Administration and Finance and was declared a failure because no prospective bidders submitted bids and application for eligibility.

WHEREAS, upon approval for re bidding, the BAC Secretariat re-advertise and/or posted an invitation to bid as provided for in Section 21.2 of Revised IRR of R.A. 9184.

WHEREAS, in response to the said re-advertisement, three (3) bidders purchased bidding documents but only two (2) bidders submitted application for eligibility and joined the bidding for the said Motor Vehicles on 17 June 2015;


WHEREAS, during the bid opening, the BAC checked the submitted documents for each bidder against a checklist of the required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion. The BAC found out that the two participating bidders failed to comply some of the requirements. Section 30.1 of the Revised IRR of R.A. 9184 provides that "Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare for the second time, **FAILURE OF BIDDING** for the Supply and delivery of Motor Vehicles for VSU Main Campus; and

- b) To recommend for approval by the President of the Visayas State University to purchase Motor Vehicles through **Negotiated Procurement** per Section 35.5 and as provided for in Section 53.1 of Revised IRR of R.A. 9184.


