## BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and Recommending Approval

## **BAC RESOLUTION NO. 11**

Series of 2015

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for Laboratory Equipment in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Four (4) bidders purchased bidding documents and joined the bidding for the said Laboratory Equipment on 25 June 2015:

**WHEREAS**, after checking the eligibility requirements, the BAC declared that all bidders *passed* the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, the BAC declared that all the bidders passed the technical requirements.

WHEREAS, after all the detailed evaluation of the technical specifications, all the bids rated passed were tabulated and ranked, the BAC identified the *Lowest Calculated Bid* (LCB) for each item (marked red) as shown in the attached Abstract of Quotation.

WHEREAS, on the same day the BAC conducted a Post-Qualification to determine the Lowest Calculated and Responsive Bid (LCRB) taking into consideration compliance of the specifications. In addition, the end users of the equipment were asked to make a justification on the choice of equipment other than the lowest bidder. The table below summarizes the results of the Post qualification:

- To declare SiTech as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item number 18;
- To declare Fil-AnaServe as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item number 17;
- d) To declare ASPEN as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item numbers: 2, 3, 4, and 7;

- To declare item numbers 1, 5, 6, 8, 9, 10 as failure for the second time and to recommend the said items for Negotiated Procurement;
- To declare item numbers 14 and 16 as failure for the first time and to recommend the said items for Re-bidding; and
- g) To recommend for approval by the President of the Visayas State University the foregoing findings.
