BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and Recommending Approval

BAC RESOLUTION NO. 13

Series of 2015

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of IT Equipment in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Two (2) bidders purchased bidding documents and submitted applications for eligibility and joined the bidding for the said IT Equipment on 14 August 2015;

WHEREAS, after checking the eligibility requirements, the BAC declared that all bidders *passed* the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, the BAC declared that all the bidders passed the technical requirements.

WHEREAS, after all the detailed evaluation of the technical specifications, all the bids rated passed were tabulated and ranked, the BAC identified the Lowest Calculated Bid (LCB) for each item (marked red) as shown in the attached Abstract of Quotation.

WHEREAS, on the same day the BAC conducted a Post-Qualification to determine the Lowest Calculated and Responsive Bid (LCRB) taking into consideration compliance of the specifications. In addition, the end users of the equipment were asked to make a justification on the choice of equipment other than the lowest bidder. The table below summarizes the results of the Post qualification:

- c) To declare item numbers **4 and 6** as failure due to no quotation offered and price quotation exceeded the Approved Budget of the Contract (ABC) per item respectively and to recommend the said items for Alternative Method of Procurement thru Shopping; and
- d) To recommend for approval by the President of the Visayas State University the foregoing findings.
