**WHEREAS**, the **VISAYAS STATE UNIVERSITY** advertised the Invitation to Apply for Eligibility and to Bid for the Construction of GYM of the Four External Campuses in a newspaper of nationwide general circulation and posted the same in the PhilGEPS, VSU Website's transparency seal, and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

**WHEREAS**, in response to the said advertisement, five (5) contractors submitted Letter of Intent (LOI) and purchased bid documents;

**WHEREAS**, on 23 June 2015, 2:00 P.M. during the bid opening, five (5) bidders submitted their bids and rated passed the preliminary examination of bids;

**WHEREAS**, after all the bids were evaluated and ranked (see attachment A), the BAC identified the Lowest Calculated Bid as shown below:
