**BAC Resolution Declaring Single Calculated and Responsive
Bid and Recommending Approval for the Supply and
Installation of E1 Line via Fiber Optic Cable at 15 Mbps
Commit Rate**

BAC RESOLUTION NO. 02

WHEREAS, the **VISAYAS STATE UNIVERSITY** re-advertised the Invitation to Apply for Eligibility and to Bid for the **Supply and Installation of E1 Line via Fiber Optic Cable at 15 Mbps Commit Rate** in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, a public bidding was held last 11 January 2016, 10:00 AM at the Conference Room of the Office of the Vice President for Administration and Finance and was declared a failure because no prospective bidders submitted bids and application for eligibility.

WHEREAS, upon approval for re bidding, the BAC Secretariat re-advertise and or posted an invitation to bid in the PhilGEPS as provided for in Section 21.2 of Revised IRR of R.A. 9184.

WHEREAS, in response to the said re-advertisement, one (1) bidder purchased bidding documents and submitted application for eligibility and joined the said bidding on 02 February 2016;

WHEREAS, during the bid opening, the BAC checked the submitted documents of the lone bidder against a checklist of the required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion. The BAC rated the documents passed the preliminary examination of bids;

WHEREAS, Section 36.a of the Revised IRR provides that "A single calculated/rated and responsive bid shall be considered for award if after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements"; and

WHEREAS, on the same date, during the Post Qualification the BAC determined the bid submitted by the lone bidder to be responsive and passes all the criteria for post qualification;

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare **INNOVE COMMUNICATION, INC.** as the **Single Calculated/Rated and Responsive Bid** for the **Supply and Installation of E1 Line via Fiber Optic Cable at 15 Mbps Commit Rate**; and
- a) To recommend for approval by the President of the Visayas State University the foregoing findings.
