**BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and
Recommending Approval for the Supply and Delivery of Construction Materials**

BAC RESOLUTION NO. 5
Series of 2016

WHEREAS, the **VISAYAS STATE UNIVERSITY** advertised the Invitation to Apply for Eligibility and to Bid for the Supply of **Construction Materials** in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, four (4) bidders purchased bidding documents and submitted applications for eligibility and joined the bidding for the said Construction Materials on 22 March 2016.

WHEREAS, after checking the eligibility and detailed evaluation of the technical component, the BAC declared, all the four (4) bidders *passed* the preliminary examination of bids.

WHEREAS, after all the bids were tabulated and ranked, the BAC identified the Lowest calculated Bid (LCB) for each item as shown in the attached Abstract of Quotation with the highlighted bid price/offer getting the LCB;


WHEREAS, on the following day, 23 March 2016, the BAC conducted a Post-Qualification to determine the Lowest Calculated and Responsive Bid (LCRB) taking into consideration compliance of the specifications. In addition, the bidders were asked to submit samples of some supplies and materials and the end users were also asked to make a justification on the choice of materials other than the lowest bidder.


NOW, THEREFORE, based on the above premises, we the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is **RESOLVED**:


- a) To declare **BRODETH**, as the Bidder with the **Lowest Calculated and Responsive Bid** for item numbers **4, 6, 14, 15, 22, 24, 30-33, 45,-47, 53-55, 61, 66, 67, 76, 80, 99 and 102**;
- b) To declare **UNI-REAL** as the Bidder with the **Lowest Calculated and Responsive Bid** for item numbers **2, 3, 17, 18, 34, 35, 39, 49, 50, 56, 58-60, 62, 65, 70, 73, 84-86, 87, 89-93 and 98**;
- c) To declare **ORMOC MAC MERCURY** as the Bidder with the **Lowest Calculated and Responsive Bid** for item numbers **1, 5, 16, 25, 36-38, 40-44, 48, 57, 64, 68, 74, 75, 77, 79, 83, 94, 96, 100 and 103**;

- d) To declare **UPTOWN** as the Bidder with the **Lowest Calculated and Responsive Bid** for item numbers **7-13, 19-21, 23, 26-29, 52, 63, 69, 78, 81, 82, 88, 95, 97 and 101;**
- e) To declare item numbers **51, 71, and 72,** as failure due to price quotation exceeded the Approved Budget of the Contract (ABC) per item and to recommend the said items for Alternative Method of Procurement thru Shopping; and
- f) To recommend for approval by the President of the Visayas State University the foregoing findings.


