**BAC Resolution Declaring Single Calculated and Responsive Bid and  
Recommending Approval for the Supply and Delivery of Filling Materials  
including Spreading and Leveling for Tolosa Campus**

**WHEREAS**, the **VISAYAS STATE UNIVERSITY** advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Filling Materials including spreading and leveling in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

**WHEREAS**, in response to the said advertisement, only one (1) bidder submitted Application for Eligibility and joined the bidding on March 28, 2016;

**WHEREAS**, after checking the eligibility and detailed evaluation of the technical component, the BAC declared, the lone bidder passed the preliminary examination of bids.

**WHEREAS**, the bidder was asked to submit additional requirements for post qualification, such as: PhilGEPS Registration, Tax Clearance and necessary permits/licences relative to soil extraction;


**WHEREAS**, Section 36.a of the Revised IRR provides that "A single calculated/rated and responsive bid shall be considered for award if after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements"; and

**WHEREAS**, on 05 April 2016, during the Post Qualification the BAC determined the bid submitted by the lone bidder to be responsive and passes all the criteria for post qualification;


**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**


- a) To declare **KAUIE BUILDERS AND CONSTRUCTION SUPPLIES** as the **Single Calculated and Responsive Bid** for the Supply and Delivery of Filling Materials including spreading and leveling for Tolosa Campus and
- b) To recommend for approval by the President of the Visayas State University the foregoing findings.


