**WHEREAS**, the **VISAYAS STATE UNIVERSITY** advertised the Invitation to Apply for Eligibility and to Bid for furnishing **CONTACT FREE DISCHARGE MEASUREMENT SYSTEM WITH CAMERA SURVEILLANCE AND DATA LOGGER** in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal, and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

**WHEREAS**, in response to the said advertisement, only one (1) bidder submitted Letter of Intent (LOI) and purchased bid documents;

**WHEREAS**, on 15 June 2016, 10:00 A.M. during the bid opening, the lone bidder submitted his bids and rated passed the preliminary examination of bids;


**WHEREAS**, Section 36.a of the Revised IRR provides that "A single calculated/rated and responsive bid shall be considered for award if after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements"; and


**WHEREAS**, on the same date, during the Post Qualification the BAC determined the bid submitted by the lone bidder to be responsive and passes all the criteria for post qualification;


**NOW, THEREFORE, We** the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**

- a) To declare **EASTASIA SOLUTIONS TECHNOLOGIES CORP.** as the **Single Calculated/Rated and Responsive Bid** for furnishing **CONTACT FREE DISCHARGE MEASUREMENT SYSTEM WITH CAMERA SURVEILLANCE AND DATA LOGGER**; and
- b) To recommend for approval by the President of the Visayas State University the foregoing findings.


