**BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and
Recommending Approval for Furnishing Laboratory Equipment**

**BAC RESOLUTION NO. 20
Series of 2016**

WHEREAS, the **VISAYAS STATE UNIVERSITY** advertised the Invitation to Apply for Eligibility and to Bid for Laboratory Equipment in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Eight (8) bidders purchased bidding documents and joined the bidding for the said Laboratory Equipment on 23 August 2016;

WHEREAS, after checking the eligibility requirements, the BAC declared that all bidders passed the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, the BAC declared that all the bidders passed the technical requirements.

WHEREAS, after all the detailed evaluation of the technical specifications, all the bids rated passed were tabulated and ranked, the BAC identified the **Lowest Calculated Bid** (LCB) for each item (marked red) as shown in the attached Abstract of Quotation.

WHEREAS, on 30 August 2016 the BAC conducted a Post-Qualification of the bidders with LCB for each item to determine the **Lowest Calculated and Responsive Bid (LCRB)** taking into consideration compliance of the specifications. The table below summarizes the results of the Post qualification:


