BAC RESOLUTION NO. 21 Series of 2016

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Installation of Digital Language Learning System for VSU Alang-alang Campus in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Four (4) bidders purchased bidding documents and joined the bidding for the said Supply and Installation of Digital Language Learning System on 24 August 2016;
