BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid and Recommending Approval for Furnishing Laboratory Equipment for VSU External Campuses

BAC RESOLUTION NO. 27

Series of 2016

WHEREAS, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for Furnishing Laboratory Equipment for External Campuses in the newspaper of general nationwide circulation and posted the same in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

WHEREAS, in response to the said advertisement, Four (4) bidders purchased bidding documents and joined the bidding for the said Laboratory Equipment on 04 November 2016 at 2:00 PM;

WHEREAS, after checking the eligibility requirements, the BAC declared that all bidders *passed* the preliminary examination of bids;

WHEREAS, upon detailed evaluation of the technical component, the BAC declared that all the bidders passed the technical requirements.

WHEREAS, after all the detailed evaluation of the technical specifications, all the bids rated passed were tabulated and ranked, the BAC identified the Lowest Calculated Bid (LCB) for each item (marked red) as shown in the attached Abstract of Quotation.

WHEREAS, on same day, the BAC conducted a Post-Qualification of the bidders with LCB for each item to determine the Lowest Calculated and Responsive Bid (LCRB) taking into consideration compliance of the specifications. The table below summarizes the results of the Post qualification:

- b) To declare LAB TRADERS as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item numbers: 8 (for VSU Tolosa Campus), 12 (for VSU Villaba Campus), and 16 (for VSU Alangalang Campus);

- c) To declare KRYPTON as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item numbers: 9 (for VSU Tolosa Campus), and 14 (for VSU Alangalang Campus);
- d) To declare HARNWELL as the Bidder with the Lowest Calculated and Responsive Bid for Laboratory Equipment, item numbers: 10 (for VSU Tolosa Campus) and 15 (for VSU Alangalang Campus;
- To declare item numbers 18 and 19 as failure for the second time due to no quotations offered by the bidders and to recommend the said items for Negotiated Procurement; and
- f) To recommend for approval by the President of the Visayas State University the foregoing findings.
