**BAC RESOLUTION Declaring the Lowest Calculated and Responsive Bid  
and Recommending Approval for the Expansion of CME Building**

**BAC RESOLUTION NO. 23  
Series of 2016**

**WHEREAS**, the VISAYAS STATE UNIVERSITY advertised the Invitation to Apply for Eligibility and to Bid for the **Expansion of CME Building** in a newspaper of nationwide general circulation and posted the same in the PhilGEPS, VSU Website's transparency seal, and in conspicuous places within the premises of the Visayas State University for 14 calendar days;

**WHEREAS**, in response to the said advertisement, six (6) contractors submitted Letter of Intent (LOI) and purchased bid documents;

**WHEREAS**, on 14 September 2016, 10:00 A.M. during the bid opening, three (3) contractors submitted their bids and rated passed the preliminary examination of bids;

**WHEREAS**, after all the bids were evaluated and ranked (see attachment A), the BAC identified the Lowest Calculated Bid as shown below:

**WHEREAS**, on 24 October 2016, the BAC Chairman assigned some BAC members to conduct background investigation on the bidders stated competence and experience as well as checking the performance of the bidder in its ongoing and completed government and private contracts.

**WHEREAS**, after all the validation, verification and background investigation, the BAC determines that the bidder with the Lowest Calculated Bid, fails the criteria for post-qualification;


**WHEREAS**, after the BAC notified the first bidder of its post-disqualification the BAC initiated and completed the same post qualification process on the bidder with second Lowest Calculated Bid;

**WHEREAS**, on 23 November 2016 the BAC determine that the bidder with second Lowest Calculated Bid passes all the criteria for post-qualification;


**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED
