Finally, let it be emphasized that the IATF created under AO 25, s. of 2011 just issued recently its Memorandum Circular No. 2019-3 dated January 18, 2021 which gave clarification on the FY 2019 PhilGEPS requirement particularly under par. 2.0 of said circular. Par. 2.1 specifically gave consideration to agencies regarding their updating of PhilGEPS requirement due to the global pandemic that seriously affected the work operations, management and compliance with PBB requirements for FY 2019 PBB.

Since the health pandemic has not been lifted yet and in fact, the local transmission in Region 8 even escalated per DOH declaration, this office would like to request consideration with regards to the non-compliance with the updating requirements in the PhilGEPS website of the above-listed procurement activities based on the explanations given in the remarks column per procurement activity.
