BOR RESOLUTION NO. 35, s. 2016

A RESOLUTION APPROVING THE ADMINISTRATIVE MANUAL OF 2010 OF THE VISAYAS STATE UNIVERSITY

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Section 7, Paragraph (a) of R.A. 9158;

WHEREAS, the Civil Service Commission (CSC) strongly enjoins State Universities and Colleges (SUCs) to formulate its own personnel policies affecting its administrative staff;

WHEREAS, this Administrative Manual of 2010 of the Visayas State University is a compilation of policies from various sources;

WHEREAS, Section 10 of R.A. 9158 stipulates that it is the duty of the Administrative Council "...to review and recommend to the Board policies governing the administration, management and development planning of the University"; and

WHEREAS, the proposal was discussed and approved on the occasion of the 119th UADCO Meeting held last 16 June 2016 at Conference Room, Office of the Vice President for Administration and Finance, 2/F Administration Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Administrative Manual of 2010 of the Visayas State University, effective upon Board approval.
