BOR RESOLUTION NO. 40, s. 2016

A RESOLUTION APPROVING THE RESEARCH MANUAL OF 2014 OF THE VISAYAS STATE UNIVERSITY

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Section 7, Paragraph (a) of R.A. 9158;

WHEREAS, the Commission on Higher Education (CHED) has classified the Visayas State University as a Level IV Higher Education Institution (HEI);

WHEREAS, the VSU is the first HEI in the country to be given Level II Institution Accreditation by the Accrediting Agency for Chartered Colleges and Universities (AAACCUP);

WHEREAS, the AACCUP requires a Research Manual as one of the requirements prior to the next level of institutional accreditation;

WHEREAS, this Research Manual of 2014 of the Visayas State University wil serve as a guide to researchers and administrators on the effective and efficient implementation of research projects;

WHEREAS, Section 10 of R.A. 9158 stipulates that it is the duty of the Administrative Council "...to review and recommend to the Board policies governing the administration, management and development planning of the University"; and

WHEREAS, the proposal was discussed and approved on the occasion of the 116th UADCO Meeting held last 16 November 2015 at University Review Center, 2/F Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Research Manual of 2014 of the Visayas State University, effective upon Board approval.
